## 2. Re-distribution of school uniforms

## 3. Completion on the student's personal record

The school needs to collect personal records of students in order to provide students with the most appropriate care (the personal information of the parents is optional). Please help your child to fill in the attachment and hand in on 3 September.

- (a) Purpose of collection: The data collected by the school concerning your child would be used solely for the purpose of health and safety managements. The information collected will be kept strictly confidential and for internal use only. The provision of personal data is optional, but if the information is not sufficient, the school may have difficulty in offering assistance to your child in case of emergency.
- (b) Request for personal information: According to Personal Privacy Ordinance, you have the right to review and revise your personal information. Please contact the school if necessary.

## 4. Student Health and Emergency Room Charges and Consent Form

In order to build up a healthy campus, the school is requesting the parents to urge your child to follow healthy diets and daily routines; take regular rest; maintain personal, household and school hygiene. If your child appears to have symptoms of upper respiratory tract infections including fever, cough and sore throat, he-she should seek for medical treatments as soon as possible and take rest at home according to the suggestions from doctors.

Whereas the public hospitals will charge the patient \$180 per attendance of Accident and Emergency services, now the school is earnestly requesting the parents to sign the consent form and allow the school to make suitable Accident and Emergency service arrangements under urgent circumstances. Thank you very much for your kind attention.

## **5. Intellectual Property and the Publication of Student Works and Photos**

In order to teach our students to respect intellectual property, the school is requesting the parents to urge your child not to plagiarize from other students, reading materials, internet or all works created by others. If any infringement is found, it will be handled as late homework submission and the scores in the related homework or tests or examinations will also be deducted. If your child needs to cite from other authors, please lists the origins for showing respect to the owner's copyright.

The school will display photos or works from students through channels like school magazines, school exhibitions or school website serving for commendation purpose. The school is earnestly requesting the parents to sign the consent form and approve the attendance of public competitions.

## **6. School Contingency Measures in The Event of Tropical Cyclones and Heavy Rain Warning Signals**

In order to ensure a safe learning environment for students, the parents should pay attentions to the following arrangements in case of tropical cyclones and heavy rain warning signals are in effect:

- (a) If Tropical Cyclone Warning Signal No. 8 or above, Red or Black Rain Signals are hoisted before school and the Education Bureau has made announcements of school suspension, the school will make school suspension announcements. Students need not attend school that day.
- (b) If the Education Bureau makes announcements of suspension during school time, the lessons are to continue. Until the situations are safe, the school will announce school suspension and students can return home alone. Therefore,
  - (i) there is no need for parents to bring your child back home under heavy rain as the school does not make announcements of school suspension, staying at school will be the safest. If the situation is safe, the school will permit the students to leave alone and it is not necessary to bring back your child.
  - (ii) If the school makes the decision of finishing the lessons earlier, the school will announce on the school website and inform the registered parents of the news through short message service (SMS). Please pay attention.
- (c) If the Hong Kong Observatory issues the Red and Black Rain Signals during school time, the school will undertake the following arrangements:
  - (i) The school will not finish the lessons earlier and all students will not leave until the end of the normal school hours. And the school will assess the situation after school and decide if it is suitable for students to return home.
  - (ii) Except for special reasons and with the presence of legal guardians, the school strongly discourages the parents to take their children home without the school's announcements of suspension, since this behavior is threatening the parents' safety and seriously affecting the students' normal studies.
  - (iii) If the school does not make announcements of school suspension, it means staying at school will be the safest. And teachers will continue their lessons as normal. If the parents are still worried about your child, please send legal guardians to register at school in person and pick up your child.
  - (iv) If the situation permits, students may have lunch out of school. If going out is considered to be dangerous, the school will make special lunch arrangements and students can buy food at the school tuck shop. And the school will extend the lunch time and allow enough time for students to buy food. All class teachers will stay at classrooms and take care of the students. The tuck shop will provide basic food such as bread, lunch boxes and noodles. As this is a special case, parents please be considerate about the inadequate selection and quality of the food provided, and understand that this is the best the school can provide. The school will not allow takeaway orders as this is unfair to some of the students and chaos will be generated.

The late delivery of the takeaway food due to bad weathers may delay normal class too.

- (v) Some students express that they are not able to buy food in the tuck shop as they don't have money with them. And the school is suggesting that parents should give a small amount of money to students daily for contingencies even if your child is having lunch at home as there are actual needs for students to use money in such cases as cited above.
- (vi) The parents should remind your child of requesting help from teachers if he-she is in lack of money and the teachers will help the students maximally to resolve the problems such as lending money or giving biscuits to students.

The school will take the students' safety into the greatest account and deploy different contingency measures. Urgent cases cannot be listed thoroughly, yet safety will be on our top priority anytime. The school is earnestly inviting the joint efforts of the parents and, please urge your child to obey the current instructions from the school and teachers. ## 7. Student Activities Support Grant

The funding is to subsidize students' life-wide learning activities such as local or overseas excursions, project learning, training courses, uniformed groups, community services and sports activities, etc.

Parents may apply for partial or full exemption of life-wide learning activity fees up to \$1,000 a year if students fulfill the following requirements:

- (a) Students who are receiving a full subsidy
- (b) Students who are granted with comprehensive social security assistance (CSSA)
- (c) Students who are in special economic needs

Parents of those students who do not meet the above requirements may still apply for a discretionary subsidy up to \$800 a year through the following procedures:

- (i) Submit a parent's letter stating clearly
  - Name of the activity
  - Subsidy applying
  - Date
- (ii) The letter is transferred to the general office via class teacher.
- (iii) The school will exercise her discretionary power in granting partial exemption of the life-wide learning activities' fee based on the following criteria:
  - Any siblings receiving half- subsidy
  - The number of siblings attending school
  - Special situation, for example: parents are unemployed
  - Others

## 3. 填寫學生個人紀錄

本校需收集學生的個人紀錄(家長個人資料可選填)，以便為學生提供最適當的照顧。請家長協助貴子弟填寫附件並於9月3日交回予班主任。

- 收集目的: 本校收集貴子弟的個人資料，只會用作處理有關學生的保健及安全事宜。收集所得的信息將嚴格保密，僅供內部使用。雖然提供個人資料與否純屬自願，但若你所提供資料不足，本校可能無法掌握貴子弟的病歷，當意外發生時，我們可能未能為貴子弟提供適切的協助。
- 索閱個人資料: 根據《個人資料(私隱)條例》，你有權要求索閱和修訂你所提供的資料。如有需要，請與學校聯絡。

## 4. 學生健康及急症室收費事宜與同意書

為建立一個健康校園，請家長敦促子弟注意遵守健康的飲食及生活習慣，作息有時，並保持個人、家居及學校的衛生清潔。若出現發熱、咳嗽、喉痛等上呼吸道感染病徵，應盡早求醫，並按照醫生建議留在家中休息。

此外，鑑於政府醫院會就急病求診個案收取每次\$180的服務費，現懇請家長簽署同意書，讓學校在緊急情況下可安排子弟到急症室求醫，以免耽誤治療時間，尚希垂注為感！

## 5. 知識產權及學生作品與相片之刊載

為使同學學習保護知識產權，懇請家長敦促子弟切勿抄襲其他同學、書報、網上或所有非本人創作之作品，如有發現，學生可視為欠交功課處理，而其功課或測驗考試所得分數亦將被扣除。若貴子弟需引錄其他作者之作品，請列明有關出處，以示尊重原創者之版權。

本校為肯定同學的成果，會於學校刊物、宣傳品、校園擺設或校網等途徑展示同學的照片及作品，並會選取優秀作品參與公開比賽。懇請家長簽署同意書，讓貴子弟的作品得以參加公開比賽。

## 6. 熱帶氣旋及暴雨警告訊號生效時學校之應變措施

為讓學生得以在安全的環境下學習，請家長注意下列有關熱帶氣旋及暴雨警告生效時之安排：

- 若八號或以上颱風訊號、紅色或黑色暴雨警告於上課前已生效，教育局已宣佈停課時，同學於該天則不用回校上課。

- (b) 若教育局於上課時間內發出停課通知，學校會照常上課，在安全情況下，學校才會宣佈停課，讓學生自行回家。因此，
- (i) 家長不需冒着大風暴雨到校接回子女，因為學校沒有宣佈停課，子女留校實為最安全的安排；若情況安全，學校會讓學生自行離開學校，家長無需到校接回子女。
  - (ii) 若學校決定於上課期間提早放學，則會於學校網頁及已登記家長之手機短訊中向家長發放消息，請家長留意。
- (c) 凡於上課時間內發出紅色及黑色暴雨警告時，學校將作下列方式處理：
- (i) 學校不會提早放學，學生會留校至下午放學時間，上課如常進行，至放學時間再視乎當時情況是否合適，學校才決定會否讓學生離開。
  - (ii) 除非有非常特殊理由，並有法定監護人到校，學校極不鼓勵家長在學校沒有宣佈停課時接走子女，此舉一來對家長自身的安危構成威脅，二者會嚴重影響學生的正常學習，懇請家長垂注。
  - (iii) 紅色及黑色暴雨警告發出時，學生會否如常於下午放學時間放學，學校會因應安全情況於學校網頁及已登記之家長手機短訊中向家長發放消息，請家長留意。
  - (iv) 若情況許可，學校會讓學生出外午膳，惟若學校認為學生出外用膳安全會受威脅時，學校會作特別安排，讓學生有秩序地到食物部購買食物充饑。學校會提早午膳時間，讓學生有足夠時間購買食物，而班主任亦會到課室照顧同學；食物部會提供足夠及基本的充饑食物，如麵包、飯盒或米粉、麵類等。鑑於情況特殊，家長須明白縱使食物味道不夠好，種類不夠多，但基於全校學生的安全考慮，這是一個本校所能安排的最可行措施。學校不會讓學生自行訂購外賣，因此舉會造成不公平及混亂，更可能因天雨關係而外賣不能於短時間送到，以致延誤上課時間。
  - (v) 有同學表示因沒有帶錢回校而未能到本校食物部購買食物，現請家長留意，縱使學生回家吃飯，本校建議家長能每日給予少量零用錢作學生應急之用，畢竟中學生需要零用錢傍身，以應付突發需要，就如上述的情況一般。
  - (vi) 不過，若同學即時未有金錢在身，請家長督請學生向老師提出請求，本校老師定當竭力幫助學生，解決基本充饑的需要，例如先借出金錢讓學生購買食物，或私下拿出餅乾讓學生充饑等。

學校一定會以全體學生的安全為最大考慮原則，作出不同的應變措施；緊急情況不能盡錄，但安全是首要原則，懇請家長與學校通力合作，並囑咐 貴子弟遵守校方及老師當下的指示。家長有任何疑問或意見，歡迎致電 2441 3818 與陳思慈副校長聯絡。

## 7. 學生活動支援津貼

學生活動支援津貼資助中一至中六學生參與全方位學習活動之費用，例如境內或境外參觀考察、專題研習、訓練課程、制服團隊、社會服務、體藝活動等。

學生如符合下列資格者，家長可向校方申請學生活動支援津貼，豁免部份或全部參與全方位學習活動所須費用，全學年上限為\$1,000。


- (a) 領取學生全額資助的學生
